Pilot Funding



Scope

1. Awards are designed to support those **that have not yet received any BRC support**
2. **Notable:** applicants that hold a **primary contract with the trust both RBH-GSTT or ICHT are eligible***

- Two types of award
- ***BRC pilot award £25,000***
- ***ECR springboard award £42,000***
- **12 months max: earliest start 1/09/2025**
- **Launch: 15th 2025**
- **Close: 16th May 2025 EOB**

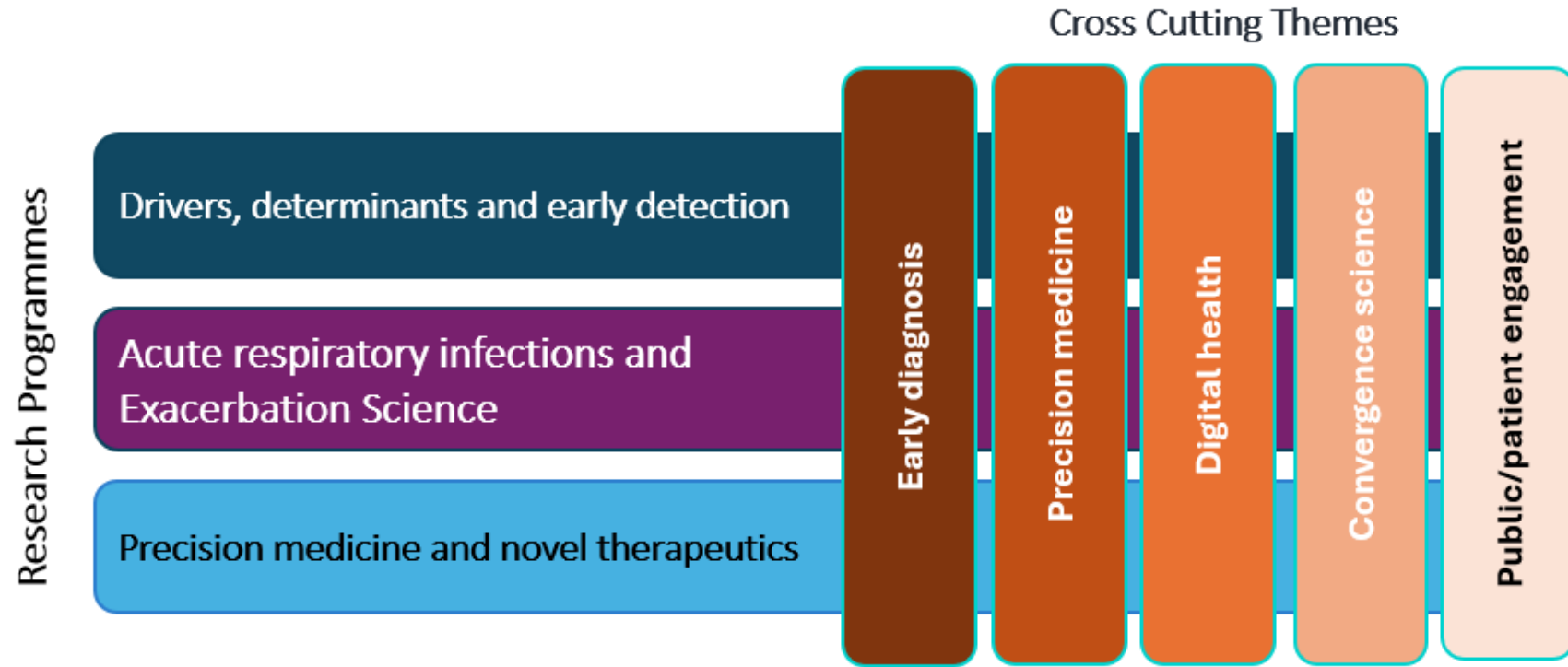

What are we looking for?

- **Pilot awards:** *Pretty much anyone doing research (PI or ECR) within the **NIHR remit**, ‘seed funding’ that will lead to successful follow-on funding ideally*
- **Early career springboard:** *Early career researchers, yet to receive major funding or BRC support - **plan to submit substantive fellowships***
- *Both awards are for a maximum period of 6 months and eligibility and funding will be prioritised to applications that can demonstrate feasibility to deliver and spend the funds within 6 months with no extensions permitted*

Alignment with the main objectives of the theme



Eligibility: both awards

1. Applicants are invited from Imperial College Healthcare NHS Trust (ICHT) and the Royal Brompton Hospital - subject to the research proposal being aligned to one of the core BRC sub-themes.
2. ICHT/RBH lead applicants must hold an honorary contract with Imperial College OR apply with a substantive college employee as co-applicant.
3. *Both awards are for a maximum period of 6 months and eligibility and funding will be prioritised to applications that can demonstrate feasibility to deliver and spend the funds within 6 months with no extensions permitted.*
4. Non-clinical applicants must demonstrate evidence that their proposal will lead to research that has/will have a direct patient benefit.
5. **Cross cutting BRC proposal with other themes (<https://imperialbrc.nihr.ac.uk/>) are encouraged** – with applicants expected to have co-developed their proposal (and discuss co-funding) with a second theme.

Additional eligibility: ECR Springboard awards

- **Applicants would typically be expected to be at the following career stages:** academic clinical lecturer, advanced fellow, lecturer (clinical or non-clinical), allied health care professional or early NHS consultant stage
- Applicants should **not** have received major funding (>£300,000) from a UKRI, Wellcome or NIHR funder.
- Applicants should **not** have received funding from the Imperial NIHR BRC for a previous springboard award.
- Applications from researchers with **established protocols, appropriate knowledge and technical expertise and personnel in place to complete and funded grant budget within 6 months will be shortlisted for funding.**
- Applicants should **demonstrate how the funding will be used to bridge successful fellowship applications and the timescales for fellowship applications.**

Additional eligibility: Pilot awards

- **Applicants would typically be expected to be at the following career stages:** professor, reader, senior lecturer, lecturer, academic clinical lecturer, advanced fellow, (clinical or non-clinical), allied health care professional or early NHS consultant stage
- Applicants should **not** have received funding from the Imperial NIHR BRC for a previous pilot award.
- Applications that **show evidence of matched funding where possible with other BRC themes or centres will be shortlisted for funding.**
- Applicants should **demonstrate how the funding will be used to bridge successful fellowship applications and the timescales for fellowship applications.**

How will we score your application?

- Rationale and background - sound hypothesis?
- Project plan & deliverables, risks/mitigation
- Operational readiness
- Potential for Impact/NIHR Remit/likely secure follow-on funding
- Resources and value for money
- ECR awards: previous high impact papers, trajectory and likelihood of securing fellowship funding?

PPIE and your application

- All applications will be scored by our Theme Community Partners following initial triage
